## **Ed Balls and Ruth Owen inspires resilience at Patron Greatness Lecture**

Patron Capital, the pan-European institutional investor focused on property-backed investments, welcomed Ed Balls, former UK Shadow Chancellor, and Ruth Owen, Chief Executive of disabled children's charity, Whizz-Kids at this month's Greatness Lecture. The lecture was a powerful illustration of the way in which disability can be overcome and a lesson in being confident in one's own skin.

Whizz-Kids is the biggest provider of powered and lightweight manual wheelchairs for disabled children outside of the NHS, and one of the leading campaigning organisations in the sector assisting the next generation in finding work and leading meaningful lives.

Ed, a patron of the charity, spoke about how he has overcome his own disability to continue working in politics. As a cabinet minister at the age of 41, he discovered he had an interiorised stammer resulting in awkward interviews on TV and criticism in parliament by his peers. Feeling embarrassed and considering it a weakness, he reluctantly saw a therapist who helped him develop a set of strategies to make his life easier and convinced him to open up about his condition.

Ruth shared her experiences as a wheelchair user from the age of seven and how she was discriminated in the workplace by both employers and clients. Ruth forged a successful career in the private sector, in technologies, eventually setting up and running her own IT company for ten years. She realised that the wheelchair was an accessory and that she was able to do everything others could but slightly differently. Most importantly, she recognised that her mind was the biggest tool and if she could apply that, she could achieve anything.
